The documents will be evaluated only on physical receipt of Tender Fee and EMD demand drafts as specified. The proposal submitted by the institutions will be opened and those institutions who are eligible after scrutiny will be selected for coaching.

The minimum qualification criteria are as under and the proposal not meeting these criteria shall be rejected:

1. The Institution should have an experience in imparting coaching to the Civil Service Examination candidates.
2. Copy of Register of Company should be attached.

4. Recognized Organizations having its centres in Puducherry region only have to apply.
5. Organizations to have well developed infrastructure to conduct the classes/ workshops and sessions smoothly keeping the needs of students in mind to meet end-to-end requirements.
6. Having proven track record of coaching with results may be enclosed.
7. Qualified Faculty with a minimum of 5 years of experience having subject teachers in each centre.
8. To conduct classes during the academic year simultaneously with academic classes and also during vocation and holidays and to complete the syllabus.
9. To provide well researched workbook or exhaustive practice material.
