

GRANT OF FINANCIAL ASSISTANCE TO THE POOR PARENTS HAVING ONLY ONE GIRL CHILD WHO IS STUDYING 8TH TO 10TH STD

1. Objective	: The scheme aims at small family norms and promoting the welfare of the girl children and treats them as an asset and to share the burden of the parents at the time of marriage of the girl child.
2. Amount of Assistance	: Rs. 25,000/- will be deposited in fixed deposit in Post Office in the form of National Savings Certificate in the name of the Girl Child. The maturity amount will be released when the girl child attains the age of eighteen years.
3. Eligibility	: <ul style="list-style-type: none"> a) The annual income of the parents from all sources shall not exceed Rs. 24,000/- b) The parents should be Indian national/should be native of Puducherry of not less than 5 years. c) Parents should produce a forwarding certificate from the Head of Educational Institution where the girl child is studying. d) Parents should produce a certificate to the effect that they do have only one girl child living and do not have any other issue.
4. Certificates to be enclosed	: <ul style="list-style-type: none"> a) Income and Residence certificates from the Revenue Department. b) Certificate from MP/MLA/Commissioner of Municipality/Commune Panchayat/Revenue Officer not below the rank of a Deputy Tahsildar c) Certificate of Birth of Girl Child d) Certificate from the Head of Institution e) Copy of the family Ration card duly attested by a Gazetted Officer f) Copy of the Election Identity Card of the parents duly attested by a Gazetted Officer g) Study certificate from the school.
5. Whom to apply	: <ul style="list-style-type: none"> a) The Deputy Director (Women Development), Department of Women and Child Development Puducherry. b) The Child Development Project Officer, Karaikal c) The Welfare Officer, Mahe/Yanam.
6. Processing time	: The selection is periodical and depends on the availability of funds.

**RULES FOR THE GRANT OF FINANCIAL ASSISTANCE
TO POOR PARENTS HAVING ONLY ONE GIRL CHILD WHO
IS STUDYING IN 8th TO 10th STANDARD**

1. *Short title, extent and commencement.*— (i) These rules may be called the "Rules for the Grant of Financial Assistance to Poor Parents having only one Girl Child who is studying in 8th to 10th Standard".

(ii) These rules shall extend to the whole of the Union Territory of Pondicherry.

(iii) These rules shall come into force with effect from the academic year 2004-2005.

2. *Definitions.*— In these rules, unless the context otherwise requires,—

(i) "Director" means the Director of Women and Child Development in the Department of Women and Child Development, Government of Pondicherry;

(ii) "Family with one girl" means a family (husband and wife) having only one girl child and does not have any other issues;

(iii) "Form" means a form appended to these rules;

(iv) "Government" means the Administrator of the Union Territory of Pondicherry appointed by the President of India under article 239 of the Constitution of India;

(v) "School" means educational institution run by the Government and private educational institution recognised and/or aided by the Government in the Union Territory of Pondicherry;

(vi) "Students" means girl students studying in Standard-VIII to Standard-X.

1 Object.— The objective of this scheme is to create awareness among the parents about the desirability of having a girl child and to raise the status of girl child in the family. The scheme aims at small family norms and to create awareness of the girl children besides preparing the parents to have a girl child and treat them as an asset and to share the expenses of bringing up the girl child.

4. *Eligibility.*— (i) The annual income of the parents from all sources shall not exceed the limit of income for the below poverty line prescribed by the Government from time to time.

(ii) Parents should produce the original Birth Certificate of the girl child.

(iii) Parents should be Indian National and should be native of the Union Territory of Pondicherry by virtue of birth or by continuous residence of not less than 5 years.

(iv) Parents should produce a certificate to the effect that they do have only one girl child living and do not have any other issue.

(v) Parents should produce a Forwarding Certificate from the Head of Educational Institution where the girl child is studying.

5. *Amount of assistance.*— An amount of Rs. 25,000 will be deposited in fixed deposit in Post Office in the form of National Savings Certificate in the name of the girl child. The National Savings Certificate will be released when she attains the age of eighteen years or at the time of marriage. The mother of the child shall be the guardian of the minor's account. If the mother predeceases, the father shall be the guardian of the minor's account. In the event that both the parents are not alive, the guardian shall maintain the minor's account. If premature death occurs to the girl child due to accident or otherwise prior to the completion of 18 years, the amount with accrued interest shall be released to the mother/father of the girl child, as the case may be, giving preference to mother if both are living.

6. *Mode of applying.*— (a) The application for grant of marriage assistance under these rules shall be made to the Deputy Director (Women Development) in respect of Pondicherry region, the Child Development Project Officer in respect of Karaikal region and Social Welfare Organisers concerned in respect of outlying regions of Mahe and Yanam.

(b) The applications shall be made in Form-I accompanied by the following certificates through the Head of Educational Institution where the girl student is studying.

(i) Income Certificate and Nativity Certificate in Form-II as detailed in rules 4 (i) and 4 (iii) above, obtained from an officer of the Revenue Department not below the rank of a Deputy Tahsildar.

(ii) A certificate in Form-II from a Member of Parliament or a Member of the Legislative Assembly or the Commissioner of Municipality/Commune Panchayat/Revenue official not below the rank of a Deputy Tahsildar, in whose jurisdiction, the applicant normally resides, to prove the conditions laid down in rule 4 (v).

(iii) Original Certificate of Birth of girl child.

(iv) Forwarding Certificate from the Head of the Educational Institution.

(v) Copy of the Family Ration Card duly attested by a Gazetted Officer, Copy of the Election Identity Card of the parents duly attested by a Gazetted Officer.

(vi) Photograph of the family duly attested by a Gazetted Officer.

7. *Competent Authority for selection of beneficiaries.*— The Director, Department of Women and Child Development, Pondicherry shall be the Competent Authority for selection of beneficiaries under these rules.

8. *Sanction of the assistance.*— (i) The filled in application forwarded by the Head of Educational Institutions, and the applicant who has fulfilled all the conditions under these rules and on sanction being accorded for the purpose by the Government the amount shall be deposited in National Savings Certificate and shall be made as per the seniority of the receipt of application subject to availability of funds under the scheme. The National Savings Certificate made in the name of the girl child shall be given to the parents, to safeguard the certificate and get back the maturity amount only when the girl child attains the age of eighteen years.

(ii) Separate registers and periodicals should be maintained by the concerned officer. Necessary entries and other details shall be made available to the Director, Department of Women and Child Development to ensure proper implementations.

(iii) The officers in the outlying regions who are authorised under these rules shall forward to the Directorate of Women and Child Development, an extract of the entries made during the month in the register maintained as required under sub-rule (ii) so as to enable to furnish quarterly and annual reports.
