

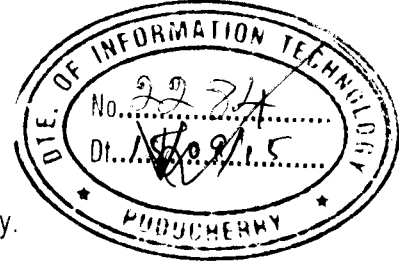

Sub: Chief Secretariat – Fisheries – Payment of Old age Pension Arrears to Fishermen for Existing beneficiaries at enhanced rate for the period of three months from June 2015 to August 2015 – Expenditure Sanction – Orders – issued.

Whereas an amount of **Rs. 5,29,36,800/- (Rupees Five Crores twenty nine lakhs thirty six thousand and eight hundred only)** has been sanctioned under the Scheme Old Age Pension for Fishermen in **two phases** viz., **Rs.1,32,34,200/-** for the months from April 2015 to June 2015 vide **Order 3rd cited** and for **Rs.3,97,02,600/-** for the months from August 2015 to March 2016 @ **Rs.1150/- per pensioner per month** vide **G.O. 4th cited**.

Whereas out of the sanctioned amount of Rs.5,29,36,800/- (1,32,34,200/- + 3,97,02,600/-), only an amount of **Rs.2,15,38,350** has been booked so far for disbursement to the beneficiaries by way of ECS for the months from **April 2015 to August 2015** and the amount available in the Head of Account is as detailed below.

Meanwhile, Notification for enhanced rates of Old aged pension with effect from June, 2015 has been issued vide **reference 2nd cited**. The difference in the amount needs to be paid to the pensioners for the period from June 2015 to August 2015.


Now therefore, in exercise of the powers conferred vide **reference 5rd cited**, sanction of the Special Secretary to Government (Fisheries) is hereby accorded for incurring an expenditure of **Rs. 94,50,510/- (Rupees Ninety four lakhs fifty thousand five hundred and ten only)** towards the payment of arrears of the enhanced rates of Old age Pension to the pensioners of Puducherry region for the period **from June 2015 to August 2015** as detailed below:-
