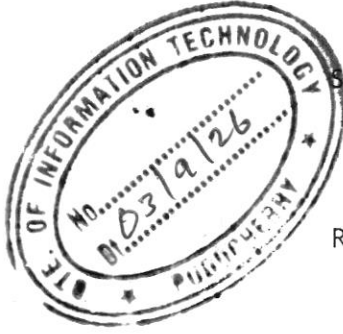

ORDER

Sub: Chief Secretariat(ADW&STW) - Grant of 2nd & 3rd instalment of House construction subsidy to 41 beneficiaries under the scheme "Pradhan Mantri Awas Yojana" to poor homeless Scheduled Caste and Scheduled Tribes" in Puducherry region - Expenditure sanction - Orders - Issued.

ORDER:

The Adi Dravidar Welfare and Scheduled Tribes Welfare Department, Puducherry, implements a housing scheme to provide financial assistance to Scheduled Caste (SC) and Scheduled Tribe (ST) beneficiaries for the construction of their own houses under the "Bharat Ratna Rajiv Gandhi Housing Scheme for Grant of Subsidy for Construction of Houses to the Homeless SC/ST & OEBC People." Under this scheme, the subsidy amount was initially enhanced from ₹2.00 lakhs to ₹4.00 lakhs vide reference 1st cited. The Central Government also implements the "Pradhan Mantri Awas Yojana (PMAY)" for house construction. The Department has dovetailed the State scheme with PMAY for availing the Central share vide G.O. 2nd cited and accordingly revised the subsidy from ₹4.00 lakhs to ₹5.00 lakhs vide reference 3rd cited. Subsequently, the subsidy amount was further enhanced from ₹5.00 lakhs to ₹5.50 lakhs vide reference 4th cited. Now, the Director has proposed the release of the 2nd and 3rd instalments for 41 beneficiaries, amounting to Rs.37,60,000/- as the State share at the rate of ₹1,60,000/- (2nd instalment) for 6 beneficiaries and Rs.80,000/- (3rd instalment) for 35 beneficiaries to enable them to construct houses under the PMAY Scheme. Accordingly, the Director has sought expenditure sanction for a sum of Rs.37,60,000/-.

2. Therefore, in exercise of the powers delegated in O.M.No.80/F3/FD/2023 dated 5-07-2023 of Finance Department, Puducherry, sanction of the Secretary (ADW & STW) is hereby conveyed to incur an expenditure not exceeding Rs.37,60,000/- (Rupees Thirty seven lakhs and sixty thousand only) towards release of 2nd & 3rd Instalment of House construction subsidy to 41 beneficiaries (2nd Instalment to 6 beneficiaries @ Rs.1,60,000/- & 3rd instalment to 35 beneficiaries @ Rs.80,000/-) to poor homeless Scheduled Caste and Scheduled Tribes people in Puducherry region being the State share under the Scheme "Pradhan Mantri Awas Yojana" who have been identified as per the procedure, to their bank account through ECS/AEPS as detailed in the Annexure- I & II.

3. The Director, Adi-Dravidar Welfare & Scheduled Tribes Welfare Department shall ensure that the terms and conditions specified in the PMAY guidelines are fulfilled.
4. The Director of Adi-Dravidar Welfare & Scheduled Tribes Welfare shall publish the list of beneficiaries with relevant details before release of each instalment of the subsidy in the official website and in the notice board of the Department.
5. The expenditure shall be debitable to the Head of Account "2225 Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities - 01-Welfare of Scheduled Castes - 789-Development Action Plan for Scheduled Castes (DAPSC) - (45) - Pradhan Mantri Awas Yojana (CSS) (State share)) - 01 -Puducherry Region (33) Subsidies" in the current financial year.
