ORDER UNDER SECTION 144 Cr.P.C.

WHEREAS, the Revenue Complex, situated at Pudupalayam Revenue Village, Puducherry has different multi faceted function viz office of the Head of Revenue Administration, Office of the District Magistrate, Office of the District Collector, Office of the District Election Officer, O/o the District Census Officer, etc., and is one of the top level office in the Puducherry which is situated in the revenue complex, Saram, Puducherry;

AND WHEREAS, apart from the Collectorate, Office of the Dy. Collector (Revenue) North, Puducherry, Court of the Sub-Divisional Magistrate (North), Puducherry, Dte. of Survey and Land Records, Puducherry, Department of Planning and Research and Dte. of Economics and Statistics etc are situated in the campus of Revenue Complex, Saram, Puducherry;

AND WHEREAS, the said campus is not provided with safe compound walls and the access control in the above said Govt. buildings is also very limited;

AND WHEREAS, Political parties, various organizations, agriculturalists, labourers, students and Govt. Servants very often resort to demonstrations etc, and at time, reach upto the building/offices, thereby threatening the security of the said buildings and officers in the buildings and such scenario encourages the agitators to conduct snap demonstrations with their available strength before the above said offices suddenly, which creates disorder and chaos;

AND WHEREAS, several incidents brought to my knowledge that the unruly agitators do not care about the normal functioning of the Govt. offices, by gathering unlawfully inside the offices and resort to conducting dharna, agitation before the chambers of the higher officials and causing inconvenience to public and hence for the maintenance of public order and smooth functioning of Govt. offices;

AND WHEREAS it appears to me that the conduct of demonstration, dharna, picketing, hunger strict etc by raising violent slogans against Government within the periphery of 200 mts surroundings of the Collectorate may likely to cause obstruction and hindrance to the Govt. officials as well as the public;

AND WHEREAS, I, am of the opinion that there is sufficient grounds for proceeding under section 144 of the Code of Criminal Procedure, 1973, to prohibit the action by any means of unlawful assembly for the purpose of conducting demonstration, dharna, hunger strike, picketing etc. by political parties, organization, associations of Govt. employees, labour unions, agriculturists, fishermen, students, or un-organized gathering etc. and also to carry any type of placards, banners, flags, sticks etc within the periphery of 200 mts surroundings of the Revenue Complex, Puducherry;

NOW THEREFORE, I, Dr. S.B. Deepak Kumar, IAS, District Magistrate, Puducherry, do hereby prohibit the conduct of demonstration, dharna, hunger strike, picketing etc. by various political parties, organization, associations of Govt. employees, labour unions, agriculturists, fishermen, students or un-organized gathering etc. and also to carry any type of placards, banners, flags, sticks etc within the periphery of 200 mts surroundings of the Revenue Complex, Puducherry with immediate effect .

This ban shall not be applicable to Govt. function, funeral processions and any other activities proposed by the Govt. Departments

This order shall be valid for 2 months from the date of publication in the Official Gazette.
