As consented by this Directorate, this is to inform that the NIC Mail Support Team (HQ), New Delhi has initiated the migration of existing e-Mail IDs from "@gov.in" and "@nic.in" to state specific domain address "@py.gov.in" with alias name. In this regard NIC, New Delhi has informed the following:

- 1. Domain "py.gov.in" will be added in the Delegated Admin Console by NIC HQ, New Delhi.
- 2. All new e-Mail accounts of Government of Puducherry are to be created with this domain by Delegated Admin Console Administrator, Puducherry.
- 3. Alias address will be added with the domain "@py.gov.in" for all existing email accounts in the Delegated Admin Console.

Existing format

New address format

: xyz@py.gov.in

- 4. Mails addressed to both xyz@gov.in and xyz@py.gov.in will be converted to primary address.
- 5. After six months period, new address with the format xyz@py.gov.in will be converted to primary address. Old address with @gov.in will be removed by NIC HQ.

Hence all the "@gov.in" and "@nic.in" domain NIC e-Mail users are herewith informed that:

- 1. Mail migration of existing e-Mail users with alias name was started on: 04-07-2022.
- 2. Effective e-Mail account of alias created with old mail address will be available up to: 04-01-2023.
