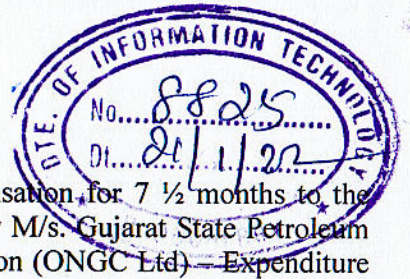

**ORDER:**

Sanction of the Lieutenant Governor, Puducherry is hereby conveyed for incurring an expenditure not exceeding an amount of **Rs. 16, 38, 41, 670** /- (Rupees sixteen crores thirty eight lakhs forty one thousand six hundred and seventy only) received from M/s. Oil and Natural Gas Corporation Limited, vide reference 5<sup>th</sup> read above, which was deposited in the Pondicherry Fishermen Welfare Distress Society, Puducherry towards disbursement of pending compensation for a period of 7 ½ months to 3354 nos of affected fishermen of Yanam region due to laying of subsea pipeline by M/s. Gujarat State Petroleum Corporation Limited time now M/s. ONGC Ltd., based on the recommendation of the Beneficiary Selection Committee, constituted for this purpose for disbursement through **ECS** mode of payment as per the list enclosed in the annexure to this order. 3. The payment shall be made to the individual accounts of beneficiaries through NEFT / RTGS.

The Assistant Director of Fisheries, Yanam will disburse the amount as per Government order through Electronic Clearing System (ECS) with due diligence within one month from the date of transfer of amount and furnish a weekly physical and financial progress report on the utilization of the compensation amount to the Director of Fisheries and Fishermen Welfare, Puducherry.
