The following notification shall be published in the next issue of the Official Gazette:-

NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to approve the proposal for enhancement of financial assistance for funeral expenses of the deceased fishermen pensioners in the Union territory of Puducherry and for the said purpose hereby further amends the "Old Age Pension for Fishermen Rules, 2003" issued vide notification under G.O. Ms. No.13/Fy, dated 11.12.2003 of the Department of Rural Development, Chief Secretariat (Fisheries), Puducherry and published in the extraordinary Gazette of Puducherry, Part –II, No.39, dated 10th December 2003 (hereinafter referred to as the said rules) and G.O.Ms.No.19/Fy, dt.30.09.2010 of the Department of Rural Development, Chief Secretariat(Fisheries), Puducherry as follows:-

1. SHORT TITLE AND COMMENCEMENT:-

- i. These rules may be called the Old Age Pension for Fishermen (Amendment) Rules, 2023.
- ii. It shall extend to the whole of the Union Territory of Puducherry.
- It shall come into force with effect from the date of publication of this Notification in the official Gazette.

AMENDMENT OF RULE 12:-

The Rule 12, shall be substituted and read as **Death of pensioner and Financial assistance** towards funeral expenses of pensioners:

In the said rule 12, the following clauses (1) to (7) shall be incorporated.

- (i) In the case of death of a pensioner, the amount of pension due to the pensioner, if any remains unpaid shall lapse. No person shall claim the unpaid amount of pension as the heir to the deceased pensioner.
- (ii) On the death of a pensioner, a financial assistance of Rs.15,000 shall be paid towards the funeral expenses of the deceased pensioner.
- (iii) The assistance shall be payable to his/her son or daughter or spouse or any other relative under whose care and maintenance, the pensioner was living at the time of his/her death.

For getting this assistance, an application shall be made in Form-VII appended to these rules, within 90 days from the date of death of the pensioner. On genuine grounds, the Director of Fisheries, Puducherry/District Collector, Karaikal/Regional Administrator, Mahe/Yanam may entertain such applications in respect of their regions beyond 90 days and upto 180 days.

- (v) The applications shall be accompanied by original Death Certificate issued by the competent authority, copies of document establishing the relationship between the deceased and the applicant, original Pension Identity Card issued by the Department, a certificate from local Panchayat President/Authorized Fisheries Official or any other responsible person of the locality to the effect that the applicant was maintaining the pensioner at the time of his death and incurred expenses towards his/her funeral and other documents as specified in Form-VII. Application tendered without the documents specified above shall be rejected.
- (vi) No payment shall be made if he has received similar assistance from any other department.
- (vii) If the deceased has not received the pension for more than three months prior to his death, the application for grant of funeral expenses shall not be entertained:

Provided that the non-receipt of pension was purely on medical grounds the Director of Fisheries, Puducherry/Deputy Director of Fisheries, Karaikal/Assistant Director of Fisheries, Mahe/Yanam, on being satisfied of the same, may entertain the application in respect of their regions.
