The Chief Medical Officer of the District may, if he/she is satisfied after such verification, enquiry or inspection, as may be considered necessary, that termination of pregnancies may be done under safe and hygienic conditions, at the place, recommend the approval of such place to the Committee. The Committee may after considering the application and the recommendations of the Chief Medical Officer of the District approve such place and issue certificate of approval in Form B.

3. The tenure of the Committee shall be for a period of two (2) calendar years from the date of issue of the order and tenure of Non-government members shall not be more than two (2) terms.
