ANNEXURE-II

TERMS & CONDITIONS FOR ENGAGEMENT OF RETIRED GOVERNMENT / SOCIETY EMPLOYEES

(IN THE CADRE OF STENOGRAPHER AS CONSULTANTS IN PONDICHERRY KRISHI VIGYAN KENDRA SOCIETY, PUDUCHERRY

- i. The consultancy service will be on full time basis
- ii. The engagement will be for a period of six months from the date of engagement and shall be extended in six monthly periods not exceeding a maximum of 2 to 5 years.
- iii. The amount of consultancy fee for the notified Government /ICAR-KVK officials engaged for the Stenographer cadre shall not exceed the ceiling of Last Pay Drawn Minus Pension and Dearness Allowance.
- iv. TA/DA on official tour will be paid as per the entitlement to his / her counterpart in Government.
- v. The appointee is entitled for leave of 12 days in a Calendar year on pro rata basis
- vi. The retired person selected for the engagement to the said post at this authority, should execute an agreement with this authority.
- vii. All expenses towards stamp duty, etc., on this agreement shall be borned by the Employer
- viii. The consultant shall not be entitled to any allowance such as Dearness Allowance, Residential Telephone, Transport Facility, Residential Accommodation, Personal staff, medical reimbursement, insurance etc.
- ix. His / her engagement as consultant shall not be considered as a case of reemployment
- x. The appointment of consultant shall be of a temporary (non-official) nature against the specific job and the appointment can be cancelled at any time by this authority without assigning any reason.
- xi. Age limit: Should not be more than 65 years.
