Sub: <u>DIT – Revamp of Department Websites as per State Portal Framework and Website Development</u> <u>Guidelines issued by Gol</u> – Reg.

With reference to the above subject, Chief Secretary (CS) made a note about the inconsistency in presentation, layout and information across various Departmental website under Government of Puducherry (GoP). He observed that lack of uniformity is causing a lot of discomfort to the citizens and other stakeholders in accessing the various services offered by the Departments. He further opined that since there is State Portal Framework and Website Development Guidelines issued by GoI, all the Departments must adhere to the same.

In this regard, he instructed the DIT to take a lead role in assisting the Departments to come under the common platform as per State Portal Framework and Website Development Guidelines issued by Gol. He had also instructed the Departments to expedite the revamp activity and update their websites before 1st January, 2014. Hence, all the departments are requested to refer the Website Development Guidelines (<u>http://india.gov.in/guidelines-indian-government-websites</u>) and the Puducherry State Portal (<u>https://py.gov.in</u>) and revamp their websites at the earliest.
