#### **TENDER CONDITIONS**

#### **A. ELIGIBILITY CRITERIA**

#### (I) ORGANISATION DETAILS

- 1. Brief information of the Contractors/Firms/Individuals/Co-operative Societies.
- 2. Name and address of the Contractors/Firms/Individuals/Co-operative Societies.
- 3. Name of Key personnel/Telephone Nos./Email I.D. and existing man power details.
- 4. Annual turnover with Audit statement for the year 2019-20.
- 5. An undertaking to the effect that the bidder has not been black listed by any Government Department/Agency/Society. The undertaking shall be in stamp paper of Rs.20/- value and signed before a Notary public. Failure to submit the undertaking will level to rejection of the bid.

#### (II) TECHNICAL CAPABILITY OF BIDDER

- 1. The bidder must have required tractor with trailer, spraying machineries and 2000 liters water tank and man power.
- 2. The bidder should have a tractor with trailer on his own or on lease.
- 3. The tractor and trailer should have valid Fitness Certificate issued by the Transport Department, Puducherry. Self Attested copy of RC Book, Fitness Certificate and Insurance should be enclosed along with the bid.
- 4. For lease tractor and trailer, lease agreement should be enclosed along with the bid.

#### **B. GENERAL CONDITIONS:**

- The tractor and trailer should have valid Fitness Certificate issued by the Transport
  Department, Puducherry. Self Attested copy of RC Book and Insurance should be
  enclosed along with the bid. FC should be renewed every year from the RTO
  concerned.
- 2. The driver should have valid driving License issued by the competent Authority.
- 3. The Spraying of Effective Microorganism (EM) Solution at Resource Recovery Park, Kurumbapet, Puducherry should be carried out as per the instruction of the Yard-in-charge of the Oulgaret Municipality. The tractor driver should also carry out the work of spraying of Effective Microorganism (EM) Solution.
- 4. Spraying of Effective Microorganism (EM) Solution should be carried out for 8 hours per day in two spells i.e.,4 hours in the morning session and 4 hours in the evening session, as per the instruction of the Yard-In-charge of the Oulgaret Municipality.
- 5. The bid should be submitted in the Online Mode only.
- 6. The Commissioner reserves the right to reject any or all the bids without assigning any reason thereof.

- 7. The rate should be quoted in Bill of Quantity (BOQ) for unit in figures and should be inclusive of all the charges such as tax, GST, transportation, loading &unloading, other incidental charges and all applicable Taxes. The bidder should arrange 2000 liters of water per day to execute the work on his/her own cost in BOQ.
- 8. Tender is valid only for 90 days from the date of opening of the tender.
- 9. Copy of the Income Tax turnover statements and auditor statements for the year 2019-20 should be submitted along with the bid.

- 11. The successful bidder shall enter into a Contract Agreement within 15 days from the date of issue of work order.
- 12. The successful bidder shall commence the work within the time frame notified by Oulgaret Municipality, Puducherry.
- 13. The Effective Microorganism (EM) Solution will be supplied by the Oulgaret Municipality, Puducherry.

#### **C. PAYMENT TERMS:**

- (i) Payment shall be made based on number of days the vehicle engaged for Spraying of Effective Microorganism (EM) Solution by engaging men and machinery at Resource Recovery Park, Kurumbapet, Puducherry
- (ii) The successful bidder should not show any shortfall in execution of work citing any payment delay on the part of the Municipality during the contract period.

#### **D. PENALTY CLAUSE**

The successful bidder should engage vehicle for spraying of Effective Microorganism (EM) Solution on all days including holidays. The work should be executed strictly as per the instruction of Yard-in-charge of the Oulgaret Municipality. Any non compliance of instruction regarding the execution of spraying work in the dumping yard issued by Yard-in-charge, Oulgaret Municipality may impose a penalty of Rs.1000/- for 1<sup>st</sup> occurrence and will double the penalty for every complaint thereafter. After 3 complaints the contract agreement will be terminated by the undersigned.

#### E. BIDDING through E – Tendering System - ONLINE SUBMISSION OF BIDS

1. The bidding under this contract shall be electronic bid submission through website <a href="http://pudutenders.gov.in">http://pudutenders.gov.in</a> Detailed guidelines for viewing bids and submission of online bids are given on the website. The invitation for Bids under this procurement shall be published on this website. Any citizen or prospective bidder can submit bids online; however, the bidder shall be required to have enrolment /registration in the website and should have valid digital Signature Certificate (DSC). The bidder should register in the website <a href="http://pudutenders.gov.in">http://pudutenders.gov.in</a> using the relevant option available. Then the Digital Signature Registration has to be done after logging into the site.

- 2. After getting the bid schedules, the Bidder should go through them carefully and then submit the documents as stipulated, failing which, the bid shall be rejected.
- 3. The completed bid comprising of documents indicated in the bid digitally signed should be uploaded in the website given above through e-tendering along with scanned copies of requisite certificates / documents as are mentioned in different sections in the bidding document.

#### F. Electronic Submission of Bids:

- (1) The cost of Tender Document of Rs. 525/- (inclusive of 5% GST) and Earnest Money Deposit (EMD) of Rs.40,000/- are to be submitted through Online Mode in favour of the Commissioner, Oulgaret Municipality only and failure to provide EMD and cost of tender document as specified here shall lead to rejection of bid.
- (2) The bid documents shall be made available in <a href="www.py.gov.in">www.py.gov.in</a> website from 11-06-2021 to 22-06-2021 at 3.30 pm. The bid document can be downloaded from <a href="http://pudutenders.gov.in">http://pudutenders.gov.in</a> at free of cost. The bids shall be opened in online on 22-06-2021 at 4.00 pm in the presence of bidders who choose to be present.
- (3) The Commissioner, Oulgaret Municipality shall be the sole authority upon all matters relating to the meaning or interpretation and consequence of the Specification and conditions of this Tender Notice (or) contract to be executed.
- (4) **Performance Security Deposit:** The successful bidder shall furnish a performance guarantee Rs.30,000/- in the form of Banker Cheque/ Pay order/Bank guarantee on receiving of letter of acceptance issued by the Oulgaret Municipality, Puducherry. The work order to the successful bidder will be issued only after receiving of Performance Security Deposit.
- (5) The EMD and Performance Security Deposit of the successful bidder will be returned only after satisfactory completion of work and after the contract period.
- (6) The contract shall not be assignable by the contractor.
- (7) The Oulgaret Municipal Council, Puducherry reserves the right to alter, cancel and add extra conditions, besides reserves the right to reject any/ all offers without assigning any reason thereof.
- (8) **Alteration in the Specification:** The specification issued with this form of tender must not be altered by the bidders.
- (9) **Incomplete Tenders:** Tender will not be considered if complete information is not given at the time of tendering or if the particulars and data (if any) called for not given within stipulated time.
- (10) Cancellation of Tender/Contract/ in part or Full in case of Default in Contract / Supply: If the contractor, in the opinion of the Commissioner, Oulgaret Municipality, Puducherry fails or neglects to comply with any of the term & conditions forming, part of the order issued, the Commissioner, Oulgaret Municipality, Puducherry shall without prejudice to any other right or remedies under the contract, has the right to cancel the contract / order by giving 15 days notice in writing to the contractor/firms without being

liable to pay any compensation for such cancellation. The Commissioner, Oulgaret Municipality reserves his right to black list the contractor if the contract is terminated due to default (or) unsatisfactory service (or) negligence (or) incompetence of the contract.

- (11) Revision of rates are not allowed after the tenders have been opened.
- (12) Conditional tenders and/or incomplete tenders in any respect shall be rejected.
- (13) **Default:** In the event of default and unsatisfactory service of the Contractors / Firms / Individuals / Co-operative Societies, the Oulgaret Municipality shall be at liberty to take up the work through other sources and claim shall be made from the concessionaire by detecting the amount from his payment.
- (14) If any of the date earmarked for opening of bid happens to be holiday, the bids shall be opened on the very next working day at the same time and venue.
- (15) The contractor shall utilize machineries of one Tractor with trailer, Genset with capacity to operate 2 HP Motor/Power take of arrangement, one 2 HP motor pump/pump, 1" hose of 100 feet length with heavy sprayer gun with minimum 18 feet coverage, 2000 liters capacity of PVC tank with water which are in good working condition.
- (16) If there is any break down in the machineries, the contractor is liable to engage any other replacement immediately at his own cost failing which Oulgaret Municipality shall engage such machinery and the cost involved shall be deducted from the payment due to the contractor.
- (17) The Contractor shall ensure that the employee of the Contractor shall not be under the influence of alcohol or any other in toxicant while on duty.
- (18) The Contractor shall ensure that he or his men or agent or employees or servants or officials shall not behave in unbecoming manner or misbehave with the officials of the Municipality or any other person at any point of time.
- (19) The Contractor shall provide safety and welfare materials to the operators, cleaners or any persons employed in connection with the deployment and operation of EM Solution spray equipments as per the standard procedures prescribed by any relevant Act and Rules in force.
- (20) The concessionaire shall be responsible and liable to adhere with all the provisions of Acts and Rules in force for his employees and heavy machineries/vehicles engaged in the yard including but not limited to
  - (a)Payment of Wages Act, 1948
  - (b) Workmen Compensation Act, 1923
  - (c)Payment of Gratuity Act, 1936
  - (d)Minimum Wages Act,1948
  - (e)Equal Remuneration Act,1976
  - (f)Employees Provident Fund Act,1952
  - (g)Contract Labour (Abolition and Regulation) Act,1970
  - (h)Employees State Insurance Act,1948
- (21)The Contractor shall insure his machineries and equipment from all probable and

possible and unforeseen accidents or incidents. The Contractor shall be responsible for every accident caused to any person or property either to his or any other men or property or equipment or to the men or employees or equipment or property of the Municipality, by the machineries and equipment and pay such compensation or damages as decided by any Court of law or Statutory Authorities and in such event of any such loss or damage to the Municipality, the Municipality shall have the right to recover the damages from the Contractor and the Municipality shall have lien on any amount pending payment to the Contractor. The Contractor shall be required to get such insurance coverage for such expenses.

- (22) All taxes, levies, cess, duties deductible from the bill of the Contractor at source shall be deducted from his bill/invoice by the Oulgaret Municipality.
- (23) The Oulgaret Municipality may deduct such penalties as computed as per the provisions of this agreement from the bill/invoice of the contract.
- (24) Any inquiries in this regard should be addressed only to the Commissioner, Oulgaret Municipality, Puducherry.
- (25) The Contractor shall not engage any person who have not completed the age of 18 years.
