NOTIFICATION

WHEREAS, Traffic P.S., Pondicherry located at Jawaharlal Nehru Street, Pondicherry is functioning under the supervision and control of Superintendent of Police (Traffic), Pondicherry and its jurisdiction extended to the whole of the Pondicherry Region of Union Territory of Pondicherry;

AND WHEREAS, it has been decided to set-up a separate Traffic P.S., at Villianur to be manned by one Inspector of Police and supporting Police Personnel such as two Sub-Inspectors of Police, four Head Constables and 23 Police Constables and to specify the jurisdiction of the proposed Traffic P.S., at Villianur.

THEREFORE in pursuance of clause (s) of section 2 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Lieutenant-Governor, Pondicherry is pleased to set-up the building at No.4, Navasanathi Street, Villianur as Traffic Police Station, Villianur and is pleased to specify, in partial modification of the notification issued in No.63-41.67- dated 24th September 1967 of the Chief Secretariat (Home Department), Pondicherry, the jurisdiction of the Traffic Police Stations at Pondicherry and Villianur as detailed
