2. The State Crisis Group (SCG) may co-opt any person whose assistance or advice is considered useful in performing any of its functions to participate in the deliberation of any of its meetings.

3. The State Crisis Group (SCG) constituted as above shall be the apex body in the Union Territory of Puducherry to deal with major chemical accidents and to provide expert guidance for handling major chemical accidents. The functions of the SCG shall be as given below.

- a) Review all district off-site emergency plans in the Union Territory with a view to examine its adequacy in accordance with the Manufacture, Storage and Import of Hazardous Chemicals, Rules and forward a report to the Central Crisis Group once in three months.
- b) Assist the Union Territory Government in managing chemical accidents at a site.
- c) Assist the Union Territory Government in the planning, preparation, response and recovery from major chemical accidents at a site in the State.
- d) Continuously monitor the post accident situation during OVE and forward a report to the Central Crisis Group.
- e) Review the progress report submitted by the District Crisis groups.
- f) Respond to queries addressed to it by the District Crisis groups.
- g) Publish a list of experts and officials in the Union Territory who are experienced with the management of chemical accidents.

3. The State Crisis Group shall meet atleast once in three months and follow such procedure for transaction of business as it deemed fit.
