INVITATION TO POST QUALIFY

On behalf of the President of India, tenders are invited through e-Tendering by the Executive Engineer, Port Department, Puducherry, for the following work from the eligible contractors/firms. Contractors ~~other than those registered with P.W.D., Puducherry~~ should produce documentary evidence in support of their having satisfactorily completed three similar works each of 40% of estimate cost put to tender or two works each of 60% of estimate cost put to tender or one work of 80% of estimate cost put to tender in the last seven years ending previous day of last date of submission of tenders. (Similar work means execution of the works of "Dredging works directly undertaken by the contractor in Government Ports, Government undertakings and Private Ports". Sub contracted dredging works undertaken by the contractor will not be considered while evaluating the eligibility criteria). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of tenders.

The contractor after purchasing the valid ikey and Digital signature Certificate can only be able to download the Press Notice, Technical and Financial Documents and other related documents and upload the bid document online by verifying the Tender Number assigned for each work from www.pudutenders.gov.in

2. The work comprises of " Maintenance dredging at Pondicherry"

3. Bidders who fulfill the following requirements shall only be eligible to apply.

Similar works means Execution of the works of "Dredging works directly undertaken by the contractor in Government Ports, Government undertakings and Private Ports". Sub contracted dredging works undertaken by the contractor will not be considered while evaluating the eligibility criteria.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at 7.00% per annum calculated from the date of completion to the last date of submission of tender.

- a) **Joint ventures are not allowed.**
- b) **Turn over:** Should have had average annual financial turnover of ₹ 10.67 Crore on dredging works during the immediate last 3 (three) consecutive financial years ending 31st March of previous financial year (100% of the estimated cost).
- c) **Profit and Loss:** Should not have incurred any loss in more than two years during the last five years ending 31st March of the previous financial year.
- d) **Solvency Certificate:** The contractor should submit a Bank solvency for an amount equal to ₹ 4.27 Crore (40% of the estimated cost).
- e) Details of organizational set up – state whether proprietorship, Partnership, private limited or public limited.
- f) Balance sheet for the past Five (5) years.
- g) Performance Certificate from previous clients.
- h) Undertaking to the effect that the applicant has never been blacklisted.

4. Desirous contractors/firms may download the Post-Qualification tender documents (Technical/Financial Bid Document) from the Website www.pudutenders.gov.in from **13.06.2023 to 06.07.2023** *The Original / attested document proof of completion certificate issued by competent authority shall be submitted to the Executive Engineer, Port Department, Puducherry on -- before 5.30 PM.*

5. The Earnest Money Deposit of ₹ 20,66,622/- (~~In cash up to ₹ 10,000/-~~) should be deposited through Direct Debit / NEFT / RTGS mode only through online in favour of the Executive Engineer, Port Department, Puducherry. ~~When the amount of Earnest Money is more than ₹ 5.00 Lakhs part of EMD is accepted in the form of Bank Guarantee also. In such, case minimum 50% of EMD or ₹ 20.00 lakh whichever is less will have to be deposited in shape prescribed above and balance amount of Earnest Money can be accepted in the form of Bank Guarantee issued by the scheduled bank having validity for 6 months or more from the last date of receipt of tenders and the successful bidder shall extend the validity of such Bank guarantee for the period of completion, plus 6 months maintenance period.~~

6. The Technical and Financial Bid Document can be downloaded from the website www.pudutenders.gov.in only by those contractors, who are having valid ikey and Digital Signature Certificate(DSC), and **the tender schedules cannot be purchased from the Office of the Executive Engineer by remitting the cash in the Office and no pre-request for issue of tender schedules will be entertained in the Office of the Executive Engineer.**

The contractors who had down loaded the Tender Schedule from the website shall submit the Tender Schedule (Technical Bid and Financial Bid) through online before the scheduled time of submission. **(No tender schedule to be sealed and brought to the Office of the Executive Engineer for placing in the Tender box). The contractor shall submit EMD and cost of tender schedule on or before closing date & time of submission of bids through online by Direct Debit/NEFT/RTGS modes.**

The three (3) covers viz. **Cover-A:** Details of cost of Schedule and EMD details, **Cover-B:** Technical bid and **Cover-C:** Financial bid shall be uploaded online before **4.00 P.M on 06.07.2023** and the Cover-A and Technical Bid (Cover-B) will be opened on **07.07.2023 at 10.30 A.M.**

The Financial bid of qualified contractors only will be opened at the notified time & date online. The bids for the work shall remain open for acceptance for a period of **90 (ninety) days** from the date of **Opening of Technical Bid.**

7. Technical bids not having valid EMD, cost of schedule and proof for eligibility criteria as mentioned, shall not be evaluated further and the financial bid documents will be disqualified in online Tender Opening.

8. If any information furnished by the applicant is found incorrect at a later stage, the tenderer shall be liable to be debarred from tendering / taking up of work in Port Department, Puducherry and forfeiting the EMD remitted absolutely without any notice. The Department reserves the right to verify the particulars furnished by the applicant independently.

9. The Department reserves the right to reject any prospective tender without assigning any reason and to restrict the list of post-qualified contractors to any number deemed suitable by it, if too many tenders are received satisfying the basic post qualification criteria.

10. ~~The Contractors who are having three works or more on hand are not eligible to participate in the tender. While tendering, the contractor should upload the declaration duly signed by them stating that, "I am not having three works or more in hand".~~

11. The Bidders should provide list of works under Execution or awarded duly signed along with the tender in "Form D".

12. ~~Other than the Puducherry PWD registered~~ The contractors shall upload the "Form C" that the statement of detail of completed works as per the eligibility criteria specified in the NIT.

13. The Executive Engineer, Port Department, Puducherry may reserve the right to change the opening time and date of the Tender for administrative reason by notifying the same in the website.

14. On the scheduled Time & date of opening, the Executive Engineer authorizes the opening of tender on the notified time. Contractor can access the particulars, after opening of tender in the web site. The Department will not be liable for any delay in submission of tender.

15. Availability of Form 7/8 in PWD website

The General Conditions of Contract for PWD Works 2014 (Form 7/8) is available on the website <https://pwd.py.gov.in/> and the same can be viewed online by the intending contractors.

16. The time allowed for carrying out the work will be **6 Months including monsoon period** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.

17. The debris should be removed from the site on day to day basis without affecting the public in general.

18. ~~The mixing of concrete should be done at a separate site avoiding stacking of material at road side.~~

19. ~~The Contractor must do their own arrangements at their own cost for signage/barricading etc. for the safety of Public during construction in the construction site of building/road/drain/canal/bridge/culverts etc. No separate claim will be admitted in this regard.~~
