TERMS & CONDITIONS FOR e-AUCTION

Disposal of unused spare parts of two, four wheeler and heavy vehicles

1. On behalf of the President of India, e-Tenders are invited for the disposal of unused spare parts of two, four wheelers and heavy vehicles belonging to the Government Automobile Workshop, Saram, Puducherry **in single lot** and 'as is where is condition' through e-auction website <https://eauction.gov.in> on **29.01.2021 from 10.00 a.m. to 4.00 p.m.** or till bid continued.

2. The intending bidders are requested to visit <https://eauction.gov.in> website for registering/creating profile for participating in the e-auction. The Tender details and terms and conditions may also be downloaded from the website <https://py.gov.in> , <https://transport.py.gov.in> for reference only. The intending bidders shall offer their bids and it will commence on the date and time given above. Each bid will be in multiples of Rs.500/- above the starting price.

3. The intending bidder who desires to participate in the e-auction shall furnish the following certificate through online and also submit in hard copy along with the two original Demand Drafts(EMD Rs.20,000/- & Application Fee Rs.315/-) to the **Government Automobile Workshop, Saram, Puducherry-605 013** on or **before the day of auction (before 27.01.2021 by 4.00 p.m.)**. **The date of scrutiny and finalization of bid document on 28.01.2021. After verification of the following document only, the bidder is admitted to participate in the e-Auction.**

- a) Valid GST Registration Certificate
- b) Pan Card
- c) Amount of E.M.D. :Rs.20,000/- (Rupees twenty thousand) by DD drawn on any Nationalized Bank in favour of “ **Drawing and Disbursing Officer, Government Automobile Workshop, Puducherry**” payable at Puducherry to qualify for participation in the e-auction. The registered bidder shall be required to upload scanned copy of DD along with necessary documents before the last date of submission.
- d) Application charge : Rs.315/-(inclusive of GST) by DD drawn on any Nationalized bank in favour of “ **Drawing and Disbursing Officer, Government Automobile Workshop, Puducherry**” Payable at Puducherry.

4. The bidders may inspect the proposed e-auction items in the Office of the Government Automobile Workshop, Puducherry in the working days of **20.01.2021 to 22.01.2021 from 10.00 a.m. to 1.00 p.m.** If the date of e-Auction happens to a public holiday it will be conducted in the next working day. No intimation will be made in this regard.

5. All the intending bidders are compulsorily required to possess Digital Signature Certificate. A free training class for the participating bidders shall be imparted at e-procurement cell at the Chief Secretariat, Puducherry/ if needed for technical clarification, contact E-procurement Help Desk No. 0413 – 2220225 / 18002337315 (Toll free).

6. The e-auction will be conducted through online. The intending bidders shall offer their bids only through online. The intending bidder should mention the address and phone / mobile number legibly for correspondence along with ID proof.

7. The intending bidders who satisfy all the condition will use (password), (user name) and alter-name to maintain their confidentiality. The intending bidder can enter his/her bid from any place at the time and date notified above by having access to e-auction site in the internet through his user name and password. The identity of the bidder will be kept confidential and bid amount alone will be displayed.

8. The Deputy Transport Commissioner-cum-Executive Engineer (i/c), GAW, Puducherry may accept the highest amount quoted. Award of the e-auction will be intimated to the successful bidder after finalization of the auction process.

9. The unsuccessful bidders (except the second highest bidder) the EMD will be refunded on the next working day and the EMD for successful bidders will be adjusted at the time of making payment.

10. The successful bidder should pay the balance amount within 3 working days, failing which the EMD amount will be forfeited and communication will be sent to the 2nd highest bidder giving opportunity to pay the 1st highest bidder quoted amount within 3 days from the date of receipt of our communication.

11. The successful bidder has no right to authorize or to transfer the right of buying the articles to another person. He should be present at the time of taking delivery of articles and sign all relevant documents and also the gate pass. This office will not be in any way held responsible for the safe custody or any loss of the sold articles.

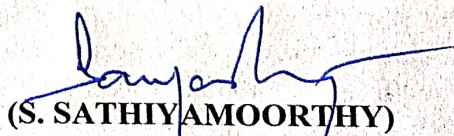
12. The articles shall be removed immediately within 24 hours by the successful bidder and must make their own arrangement for transporting the articles at their own cost once the auction is finalized after making full payment. Loading shall be arranged by buyer himself. No claim about the condition, Quantity, Quality and value of the articles will be entertained once the auction is finalized.

13. The successful bidder should pay the cost of the articles and applicable GST. If the Government introduces any fresh taxes or increases the present rates of taxes, the same has to be paid by successful Tenderer.

14. Tenderers should take into account any corrigendum published on the tender document before submitting their bids.

15. All the cases of dispute, if any, will be settled subject to jurisdiction of Puducherry region.

15. In case of any dispute arising from the said e-auction, the decision of the Deputy Transport Commissioner-cum-Executive Engineer (i/c), Government Automobile Workshop, Transport Department, Puducherry will be final and also reserves the right to accept or reject any bids or cancel the auction without assigning any reason thereof.
