3. Qualification for Members of Juvenile Justice Boards (JJBs) as per Rule 04 (3) of Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017:

Qualification & Experience as per Rule 4(3) of Puducherry JJ Rules,2017.	shall have at least seven years of experience of working with children in the field of education, health or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in
	the field of law.
	Shall not be less than 35 years and not more than 65 years of age at the time of appointment.

^{*} If the candidates apply for more than one post, separate application form shall be submitted.

Note: The appointment will be subject to the provisions under Rule 16 & 4 of Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017. The Chairperson & Member of the CWC and Members of JJB shall be appointed by the Government on the recommendation of the Selection Committee under **rule 91** of these rules.

(C) Eligibility Criteria: -

- I. Native/Resident of Union Territory of Puducherry only need to apply for the posts mentioned in the notification.
- II. The candidate having the necessary qualification and experiences as per rule 4(3) & 16(3) of the Puducherry JJ Rules, 2017, only needed to apply for the posts as mentioned in the Notification.
- III. The candidate fulfilling the required qualification and experiences will only be called for certificate verification & Interview.
- IV. The selected candidate has to <u>produce the police verification report/ certificate</u> and <u>resident certificate</u> before constitution of the Committee/ Boards.

(D) PAYMENT OF MONTHLY REMUNERATION: -

V. As per rule 18 of the Puducherry JJ Rules,2017, the Chairperson and Members of the CWC and Members of JJB shall be paid such sitting allowance, travel allowance and any other allowance, as the Government may prescribed but not less than Rs. 2000/- per Sitting. (20 sittings maximum per month).

(E) Tenure of the Committee/ Boards:-

VI. As per rule 5 & 17 of the Puducherry JJ Rules,2017, the Committee / Board shall have a tenure of three years and the tenure of Chairperson and Members of the Committee and Members of the Boards shall be co-terminus with the tenure of the committee.

(F) Other Conditions: -

The person applying for the post of the Chairperson or Member of the Committee or Member of the Board shall submit an affidavit, as per Form 49, certifying that the applicant is not barred by any of the condition laid down in Sub- Section 4A of Section 27 of the Juvenile Justice (Care and Protection of the Children) Amendment Act,2021 and the same is available in the website-https://www.py.gov.in. Applications received after the prescribed date and time limit will not be Considered.

(H) Selection Process: -

The Chairperson and Members of Committee and Members of Boards will be selected by the Selection Committee for selection of Chairperson and Members of CWC/ JJB as per Rule 92 of the Puducherry Juvenile Justice (Care and Protection of the Children) Rules, 2017
